

Guidelines for the Submission of Proposals

I. Eligible applicants

The Call for Implementing Partners is open to registered CSOs working in BiH. Applications are encouraged particularly from women's and human rights organizations.

Priority will be given to:

- Women's CSOs/ Women's CSOs network and platforms that have specialized knowledge, expertise and track record of working in women's human rights and ending VAWG;
- Women's CSOs/ Women's CSOs network and platforms with track record in working in service provision to survivors of VAW and domestic violence, referral mechanisms and multi-sectoral coordination

Important notes:

- Each application can only be submitted by a single organization.
- Proposals from more than one organization or entity must clearly indicate which organization will take lead responsibility for project management and contractual obligations.
- Transfer of funds by the Applicant Organization to UN Agencies, private sector entities, International NGOs and International Organizations will not be allowed.
- UN Women will sign contracts with and disburse funds to the applicant organization only.
- Eligible organizations currently partnering with UN Women may apply under this call for proposals.

Non-eligible applicant organizations

The following are **NOT eligible** to apply to this call for proposal:

- Government agencies or institutions
- UN agencies
- Bilateral or multilateral organizations, financial institutions, development agencies
- Private sector entities
- Private individuals
- CSOs not focused on gender equality and women's empowerment
- CSOs with lack of gender balance in their staff, board membership and leadership positions.

II. What to submit

Eligible applicants are expected to submit the following in English using the Application Form and budget template:

1. General Information including name of organization, contact person and contact details

2. Project proposal consisting of:

- Institutional profile, including a brief description of your institution, its registration details and relevant experience addressing EVAWG issues;
- Partnerships: a description of the partners needed to successfully implement the project and their roles;
- Context and problem analysis;
- Project Design and Justification;
- Results the project aims to achieve;
- An output-based budget **in local currency**, i.e. budget showing how much is required for each activity to achieve each output. The administrative/indirect cost should not exceed 7% of the total budget. Minimum budget of the proposal should be EUR 55.000 and the maximum should not exceed the amount of EUR 60.000.

3. A copy of the organization's **legal registration document**

4. **Supporting documents** such as your organizational brochures, previous annual reports and audit reports from the past three years.

III. Evaluation Criteria

Proposals passing the eligibility criteria (see above) will be scored against the following:

- **Relevance of the proposal (20 points):** quality of the context analysis; and pertinence of the proposed activities against expected results
- **Implementation strategies (30 points):** linking local implementation to national, regional and international commitments; utilizing a rights-based approach; using strategic partnerships; and engaging marginalized groups;
- **Added value elements (20 points):** previous work on service provision to survivors of VAW and domestic violence, referral mechanisms and multi-sectoral coordination;
- **Budget Proposal (20 points)**
- **Innovative approaches (10 points)**

Minimum score to be eligible is 70 points.

Only applicants passing the minimum score will be contacted to proceed with shortlisting and a capacity assessment review. During the capacity assessment review, the applicant will be requested to submit documents demonstrating the organization's technical capacity, governance and management structure, financial and administrative management.

IV. When is the proposal due

The deadline for submission of proposals is 06 September 2017. Proposals received after the deadline will not be considered.

V. To whom should the proposal be sent
