




# IMPLEMENTING NORMS CHANGING MINDS

For the fourth year in a row, the Regional Forum on Ending Violence against Women in the Western Balkans and Türkiye "Integrated Policies, Inclusive Partnerships" was hosted with an aim to advance the gender equality agenda towards preventing and responding to violence against women in the region. Organized virtually on 29-30 November 2022 within the 16 Days of Activism against Gender-Based Violence, the Forum brought together over 300 participants including state representatives, civil society and regional organizations, ombudsperson offices, and well-respected figures from cinema, literature, and sports from across the Western Balkans and beyond.

# NEW PROTOCOL FOR RESPONDING TO SEXUAL VIOLENCE CASES LAUNCHED IN KOSOVO\*

The state Protocol for Treatment of Sexual Violence Cases in Kosovo was launched in December 2022 as part of the 16 Days of Activism against Gender-Based Violence campaign activities in Kosovo. Under the "Implementing Norms, Changing Minds" regional programme on ending violence against women, funded by the European Union, the UN Women provided support in drafting this important document from its initial stages.


### INTERVIEW: "ADDRESSING VIOLENCE AGAINST WOMEN REQUIRES LONG-TERM COMMITMENT, CAPACITIES, AND HUMAN AND FINANCIAL RESOURCES"

Anjeza Bojaxhiu is the local coordinator of the domestic violence referral mechanism – a dedicated mechanism that aims to protect and support survivors of violence, composed of a team of community professionals in Tirana, Albania. With extensive experience in good local governance and social services for women and girls from disadvantaged groups, Ms. Bojaxhiu shares the most promising



practices related to establishing and operating local referral systems as well as ways to address challenges that may arise. ## FIRST FEMICIDE INTERACTIVE MAP FOR ALBANIA. **MONTENEGRO AND SERBIA LAUNCHED**

An interactive map listing femicides committed since 2019 in Albania, Montenegro and Serbia was launched within the framework of the Fourth Regional Forum: Ending Violence against Women in the Western Balkans and Türkiye

on 29-30 November 2022. Femicide is the killing of a woman because she is a woman, committed on the grounds of her sex or gender, and is rooted in unequal power relations between men and women. Developed by the organization FemPlatz with the support of the regional programme on ending violence against women "Implementing Norms, Changing Minds," funded by the European Union, the interactive map aims to track data on femicides in Albania, Montenegro and Serbia as well as to serve as a model for a tool that can be used by prospective femicide watches – mechanisms to monitor femicide – in the region.
