DRAFT CONCEPT NOTE

I. Background

The sixty-eighth session of the Commission on the Status of Women (CSW) will take place from 11 to 22 March 2024. Representatives of Member States, UN entities, and ECOSOC-accredited non-governmental organizations (NGOs) from all regions of the world are invited to contribute to the session. The CSW, a functional commission under the United Nations Economic and Social Council (ECOSOC), is dedicated to advancing global gender equality and the empowerment of women.

The Agreed Conclusions are the primary outcome document of the CSW. The Agreed Conclusions are negotiated in an inter-governmental process between United Nations Member States. Most of the negotiations occur during the second week of CSW, although important parts of the process occur in the lead-up as well. The final document includes an analysis of the CSW priority theme and a set of concrete recommendations on the theme and gender equality for governments, intergovernmental bodies and other institutions, civil society actors and other relevant stakeholders to be implemented at the international, national, regional and local level.

The priority theme for CSW68 is "Accelerating the achievement of gender equality and the empowerment of all women and girls by addressing poverty and strengthening institutions and financing with a gender perspective." The outcome of the Commission's consideration of the priority theme during its 68th session will take the form of agreed conclusions to be negotiated by all Member States.

This thematic focus underscores the critical intersectionality between economic well-being and governance practices that are responsive to gender dynamics. The discussions will be informed by the Secretary-General Report on the Priority Theme. Concurrently, the session will review progress under the theme, "Social protection systems, access to public services and sustainable infrastructure for gender equality and the empowerment of women and girl", which was the priority theme of CSW63 and its agreed conclusions.

Recognizing the imperative to engage in substantive and inclusive dialogues that span diverse sectors of society, the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women) and the Senate of the Republic of Uzbekistan will collaboratively convene subregional multistakeholder consultations for Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan.

These consultations are strategically positioned as a preparatory initiative for CSW68, seeking to foster comprehensive discussions and collaboration among various stakeholders to address the multifaceted challenges and opportunities central to advancing gender equality in the region, and more specifically on the priority theme.

The consultations will specifically address challenges and opportunities in accelerating Gender Equality and Women's Empowerment (GEWE) by focusing on poverty alleviation, strengthening social protection, unveiling and addressing unpaid care work, women's participation in the labor force, and financing and investing with a gender perspective. In addition to these key areas, the initiative will also delve into critical aspects such as education and skill development.

II. Objectives of the Consultations

The subregional multistakeholder consultations have the following key objectives:

- 1. To assess the status of gender equality in relation to the priority theme in the Western Balkans and Türkiye, considering the unique challenges and opportunities of the region.
- 2. To identify Central Asia sub-regional priorities and strategies for advancing and financing GEWE in relation to the care economy, unpaid care work, social protection, and labor force.
- 3. To facilitate a dynamic exchange of ideas among various stakeholders, including government representatives, civil society, academia, and the private sector.
- 4. To contribute to the development of concrete messages and recommendations for the CSW68 session.

III. Outcome

The half-day consultation is expected to produce a document with a comprehensive set of **messages, best practices, and concrete recommendations** that will inform the Central Asian sub-region's (Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan and Uzbekistan) contribution and participation to CSW68.

The document will be shared with all delegations, participants, and relevant stakeholders, contributing to a more inclusive and impactful global conversation on advancing gender equality ahead of the meeting and serve as basis discussions and review for endorsement.

IV. Target audience

The consultations will bring together a diverse group of participants, including:

- 1. High level officials and technical staff responsible for gender equality and women's empowerment and involved in the topics addressed by the priority theme, including poverty, social protection, unpaid care work, women's participation in the labor force, and financing and investing in gender equality and women's empowerment.
- 2. Representatives from civil society organizations, including youth-led organizations with a proven track record on the topic.
- 3. Academics and researchers specializing in issues pertaining to the priority theme.
- 4. Private sector representatives committed to promoting gender equality and economic empowerment of women.

V. Content and format of the Consultations

The consultations will consist of two panel discussions focusing on the priority theme. Participants will have the opportunity to share best practices, discuss challenges, and propose innovative solutions. Emphasis will be placed on fostering collaboration and partnerships among stakeholders to accelerate progress towards gender equality.

The discussions will focus on the following sub-themes:

- Embracing Intersectionality in Addressing Poverty, Strengthening Institutions, and Financing with a Gender Perspective.
- Bridging Financing Gaps for Gender Equality and Women's Empowerment: Building Capacities and Spaces to Influence Policies and Budgets for Gender Equality.
- Tackling Disproportional Burden and Unpaid Domestic and Care Work: Shifting Towards Care Economies.
- Social protection systems and services.

The discussion will be informed by background documents listed in Annex I.

Format

The half-day session will be online with the possibility of in-person participation for attendees from Uzbekistan at Palace of Forums.

Languages

The meeting will be in Uzbek, Russian and English with simultaneous translation.
