## BEIJING+30: STRATEGIC LEVEL RESULTS



••••

In 2025, the global community will commemorate the 30th anniversary of the Fourth World Conference on Women and the adoption of the Beijing Declaration and Platform for Action. This landmark event, known as Beijing+30, serves as a pivotal moment to reflect on the progress made towards gender equality and to renew commitments for the future.

The Beijing Declaration and Platform for Action outlines strategic actions across 12 critical areas of concern, including poverty, education, health, violence, armed conflict, economics, power and decision-making, institutional mechanisms, human rights, media, environment, and the girl child.

The Beijing+30 Strategic Level Results highlight a multifaceted approach to advancing accountability, recommitment and resources through powerful communication, public engagement and advocacy campaign:

- Member States: A package of evidence-based, well resourced, high-impact and timebound
  actions is taken up to accelerate the Beijing Declaration and Platform for Action and
  Sustainable Development Goals, in partnership with other stakeholders.
  - **Women's Rights, Young People & Civil Society Organizations:** Women's Rights Organizations, Youth Movements, and Civil Society Organizations influence action, claim rights, and are resourced.

**Multilateral System:** The Multilateral System better delivers on gender equality, women and girls' rights and empowerment, and scale up implementation of the Beijing Declaration and Platform for Action & Sustainable Development Goals.






Decriminalization of domestic violence

- By 2025, all people in Kazakhstan, especially the most vulnerable, are empowered with knowledge and skills to equally contribute to the sustainable development of the country.
- By 2025, all people in Kazakhstan are protected and enjoy full realization of human rights and gender equality and a life free from discrimination, violence and threats, and equally participate in decision-making.
- By 2025, state institutions at all levels effectively design and implement gender-sensitive, human rights and evidence-based public policies and provide quality services in an inclusive transparent and accountable manner.



#### WE STRIVE FOR

- Adapting and implementing the Sustainable Development Goals into relevant national and local strategies and policies.
- Eliminating gender-based violence and harmful practices, harmonizing laws on domestic violence to international standards, and criminalization of domestic violence.
- Introducing gender aspects into all processes of national and local planning and budgeting.
- Empowering women in politics and economics.
- Increasing women's presence at decision-making level in all areas and advocating for a gender guota with a minimum threshold of 30%.
- Empowering women and girls from vulnerable groups and rural areas.
- Addressing women unemployment and unpaid carework.
- Building capacity for civil society and state insitutions.
- Embedding gender inequality into climate change strategies and actions, introduction of gender aspects in preventing and mitigating risks for all types of disasters.

- Strengthening disaggregated data collection, monitoring and analysis.
- Combating violence and harassment in the world of work, addressing patriarchal norms, harmful gender stereotypes and promoting progressive social norms.
- Engaging men and boys in positive practices to empower women and girls.
- Mobilizing private sector in women empowerment initiatives.
- Strengthening capacity of youth and engage them into promotion of GEWE agenda countrywide, with focus on rural areas.
- Increasing outreach to youth through academia.
- Enhancing gender expertise through education system.
- Mobilizing experts and media professionals, public opinion leaders, celebrities, community activists and social influencers for grassroot changes.
