c. UN Women Terms of Reference

1. Introduction

a. Background/Context for required services/results

Phase II of the regional programme, 'Implementing Norms, Changing Minds' aims to end gender-based discrimination and violence against women (VAW) in the Western Balkans (Albania, Bosnia and Herzegovina, Kosovo*, Montenegro, the Republic of North Macedonia and Serbia) and Turkey, with a particular focus on the most disadvantaged groups of women. The Programme is anchored in the normative frameworks of the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) and the Council of Europe Convention on preventing and combating VAW and domestic violence (Istanbul Convention)¹, and is also in alignment with EU accession standards. The Programme is funded by the European Commission within the Instrument for Pre- Accession Assistance (IPA) II.

The programme supports the development of an enabling legislative and policy environment on eliminating VAW and all forms of discrimination; promotes favorable social norms and attitudes to prevent gender discrimination and VAW; and pursues empowering women and girls (including those from disadvantaged groups) who have experienced discrimination or violence to advocate for and use available, accessible, and quality services. The programme channels its interventions through and for civil society organizations (CSOs), in particular women's organizations, with an emphasis on those working and representing women from minorities and disadvantaged groups. Phase II is expected to last eighteen months and will start the day after Phase I of the programme (February 2017 to January 2020) ends.

As a State Party to CEDAW, based on general recommendations no. 19 and 35 of the CEDAW Committee, Turkey has an obligation to both prevent VAW and provide support and redress for survivors of violence. In terms of regional mechanisms, the Istanbul Convention, which Turkey ratified in 2012, is the only international treaty that solely seeks to tackle VAW. It includes multiple obligations that are linked with the establishment and provision of services for survivors of VAW.

The Istanbul Convention distinguishes between general and specialist support services. Furthermore, Article 19 of the Convention outlines the requirement for adequate and timely information on available support services and legal measures that must be made available and understandable for survivors; for instance, through translations of available information into languages that survivors understand. Adequate information must clarify where survivors can receive specific types of help (in languages other than the national language(s), if necessary) and must be available in a timely manner, implying at a time when survivors need to access it.

In line with the requirements of Law No. 6284, Turkey's support services are comprised of Violence Prevention and Monitoring Centers (ŞÖNİMs), first admission stations, women's shelters and other services. The 2018 GREVIO Baseline Report recommends that Turkey should take measures to ensure that "(1) protection and support services are based on a gendered understanding of violence and through training and other appropriate means relevant service providers are developed specialist capacities/skills to recognize the gendered dynamics, impact and consequences of violence; (2) protective measures contribute to the empowerment of victims and (3) in addition to state-run services, alternative, low threshold specialist services, namely services provided by NGOs, are available."²

The GREVIO Baseline Evaluation Report called on Turkey to "promote programmes and activities for the empowerment of women and girls by countering discriminatory stereotypes, as a means of upholding their right to live a life free of violence," while also engaging men and boys to promote women's equality and prevent VAW. In particular, the report suggests that Turkey should develop awareness-raising programmes that involve the active contributions of women's CSOs in the design and implementation processes, promote gender-sensitive teaching materials and closely monitor the usage of these materials, and design and implement systemic and mandatory in-service training on VAW for professionals.³

Civil society organizations, in particular women's organizations, play a crucial role in the promotion of gender equality and women's rights. They are key advocacy stakeholders that force governments to move from commitment to international normative standards to their implementation. They are also key stakeholders in the provision of services that are essential in the establishment of multi-sectoral and coordinated mechanisms to adequately respond to the needs of victims of violence. Furthermore, women's organizations are instrumental in bringing to the attention of policy makers the perspective and voices of all women and in facilitating the required behavioural and attitudinal changes for tackling the structural barriers that are in the way of achieving gender equality and ending VAW

Where multiple discriminations are present, women's access to available services is more limited. More efforts are needed to ensure that justice services and any specialist services provided to women survivors of violence are in line with the Istanbul Convention standards, and that women are able to access those services without any burden and experiencing secondary traumatization.

b. General Overview of services required/results

The commitments made through the Istanbul Convention are seen as an opportunity for progress by many actors in the region, particularly in Turkey. The Convention provides a clear road map and an operational recipe for implementation and requires the active involvement of civil society. Furthermore, it recognizes the greater risk faced by groups of women who are subject to intersectional discrimination (e.g. refugee and migrant women, women with disabilities, women living in rural areas, women from ethnic minorities, etc.) and calls for the effective cooperation of state agencies with CSOs.

A major challenge in the protection of the rights of women is the low awareness and/or implementation regarding laws and policies, both amongst enforcement agencies and the general population. The European Commission (EC) notes that although there is a legislative and institutional framework on gender equality in place, there is a gap between existing framework and its implementation. This gap results in low quality of support services available. The EC also draws attention to "the lack of strong political commitment to gender equality, exemplified by frequent public statements of high-level officials reflecting a conservative view of the role of women." In this context, awareness-raising campaigns in the fight against stereotypes, discrimination (including gender-based) and domestic violence, and in the fight for gender equality in general are of the utmost importance.

This is particularly true for marginalized women who often lack knowledge about their rights and the services available to them, which leads to low levels of assertiveness in claiming their rights. The 2007 General Assembly resolution on the Intensification of Efforts to Eliminate All Forms of Violence against Women calls on states to give regard to women who need special attention in the development of policies to address violence, such as women belonging to minority groups, including those based on ethnicity, and migrant women.⁵

During Phase I, the regional programme, 'Implementing Norms, Changing Minds' endeavored to support women's access to quality services. This involved building the capacity of female lawyers, working as pro bono legal support to survivors of VAW, to familiarize them with and encourage their use of the Istanbul Convention, CEDAW, and relevant European Court of Human Rights decisions. In order to widen and institutionalize this access to justice, the programme subsequently included the Bar Association in this activity, particularly lawyers in women's rights centers. Additionally, the programme supported case and fact-based data collection on women's rights to alimony after divorce, to contribute to the current public debate on this issue. Finally, the programme supported the dissemination of existing legal rights and mechanisms for survivors of VAW in Turkey to the Syrian women refugee community, reaching out to 1,276 Syrian women.

Bearing in mind that more efforts are needed to ensure the quality of service provision and women's access to services, UN Women is issuing a Call for Proposals (CfP) to select a responsible party to contribute to the programme Specific Objective 3: To empower women and girls (including those from disadvantaged groups) who have experienced discrimination or violence to advocate for and use available, accessible and quality services and more specifically to Output 3.3: Better access to and improved service provision for women from minority and disadvantaged groups.

The overall goal of this Call for Proposals is to increase women's access to justice and/or specialist services in Turkey, particularly the most marginalized groups of women.

The expected result of the project is increased knowledge regarding and access to justice and/or specialist services that are available for women survivors of violence and discrimination, particularly for the most marginalized groups of women.

2. Description of required services/results

The planned interventions will focus on promoting the right of women to receive information about available justice and specialist support services for survivors of violence. Furthermore, the planned interventions will promote access to those services, address state and non-state service providers' capacity building needs and develop models for the establishment of non-existing services in line with the Istanbul Convention (e.g., rape crisis centres, risk assessment and management mechanisms, etc.). With a view to achieving **output 3.3: Better access to and improved service provision for women from minority and disadvantaged groups,** it is expected that the selected CSO will, inter alia:

- Ensure the provision of services is based on a gendered understanding of violence, is not dependent on the survivors' decision to press charges, and targets survivors' empowerment;
- Ensure the information provided to survivors is comprehensive, practical, and tailor-made, to ensure
 their immediate access to support, and to guide them with accurate information through their decisionmaking process;
- Ensure support services are offered in a wide spectrum and are in line with the Istanbul Convention's quality standards:
- Design and implement innovative cutting-edge campaigns to inform women about their rights and justice services available to them, including marginalized women;
- Improve information systems for women to seize opportunities to access justice, including marginalized women.
- Ensure that women, and in particular marginalized women, are informed about local and national referral
 mechanisms for victims of sexual and gender-based violence and how to gain access to the formal justice
 mechanism.

All knowledge products and communications materials that would be produced under this agreement must acknowledge the support of and seek the approval of UN Women. Furthermore, they should be in line with the EU Communication and Visibility tools and the EU-UN joint visibility guidelines.⁶

3. Timeframe: Start date and end date for completion of required services/results

The project is expected to be carried out within the months of April 2020 and April 2021.

4. Competencies: [Please elaborate]

- a. Technical/functional competencies required;
 - Rights-based organizations that are legally registered in Turkey and have specialized knowledge
 and expertise, as well as a track record of working in women's human rights and ending VAW
 programming, including but not limited to: non-governmental organizations, community-based
 organizations and advocacy networks (at national or sub-national level);
 - Other CSOs that are legally registered in Turkey and have previous experience in a) provision of services to survivors of violence and/or b) engaging with communities on changing gender harmful stereotypes;
 - The CSO will be selected only if it has proven capacity to deliver the proposed activity. The CSO's capacity will be assessed by UN Women as per UN Women's policies, rules and regulations.

a. Instructions to proponents (Implementing Partners)

1. Introduction

- 1.1. UNWOMEN invites qualified parties to submit Technical and Financial Proposals to provide services associated with the UNWOMEN requirement for (Implementing Partner).
- 1.2. UNWOMEN is soliciting proposals from Civil society Organization (CSOs). Women's organizations or entities are highly encouraged to apply.
- 1.3. A description of the services required is described in CFP Section 1 C "Terms of Reference".
- 1.4. UNWOMEN may, at its discretion, cancel the services in part or in whole.
- 1.5. Proponents may withdraw the proposal after submission, provided that written notice of withdrawal is received by UNWOMEN prior to the deadline prescribed for submission of proposals. No proposal may be modified subsequent to the deadline for submission of proposal. No proposal may be withdrawn in the interval between the deadline for submission of proposals and the expiration of the period of proposal validity.
- 1.6. All proposals shall remain valid and open for acceptance for a period of 120 calendar days after the date specified for receipt of proposals. A proposal valid for a shorter period may be rejected. In exceptional circumstances, UNWOMEN may solicit the proponent's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.
- 1.7. Effective with the release of this CFP, <u>all</u> communications must be directed only to turkey.procurement@unwomen.org. Proponents must not communicate with any other personnel of UNWOMEN regarding this CFP.

2. Cost of proposal

The cost of preparing a proposal, attendance at any pre-proposal conference, meetings or oral presentations shall be borne by the proponents, regardless of the conduct or outcome of the CFP process. Proposals must offer the services for the total requirement; proposals offering only part of the services will be rejected.

3. Eligibility

Proponents must meet all mandatory requirements/pre-qualification criteria as set out in **Annex A-1** (See point 4 below for further explanation). Proponents will receive a pass/fail rating on this section. To be considered, proponents must meet all the mandatory criteria described in **Annex A-1**. UN WOMEN reserves the right to verify any information contained in proponent's response or to request additional information after the proposal is received. Incomplete or inadequate responses, lack of response or misrepresentation in responding to any questions will result in disqualification.

4. Mandatory/pre-qualification criteria

- 4.1 The mandatory requirements/pre-qualification criteria have been designed to assure that, to the degree possible in the initial phase of the CFP process, only those proponents with sufficient experience, the financial strength and stability, the demonstrable technical knowledge, the evident capacity to satisfy UNWOMEN requirements and superior partners' references for delivering what is envisioned in this CFP will qualify for further consideration. UNWOMEN reserves the right to verify any information contained in proponent's response or to request additional information after the proposal is received. Incomplete or inadequate responses, lack of response or misrepresentation in responding to any questions will affect your evaluation.
- 4.2 Proponents will receive a pass/fail rating in the mandatory requirements/pre-qualification criteria section. In order to be considered for Phase I, proponents must meet all the mandatory requirements/pre-qualification criteria described in this CFP.





5. Clarification of CFP documents

A prospective proponent requiring any clarification of the CFP documents may notify UNWOMEN in writing at UNWOMEN email address indicated in the CFP by the specified date and time. UNWOMEN will respond in writing to any request for clarification of the CFP documents that it receives by the due date outlined on **Section 1**. Written copies of UNWOMEN response (including an explanation of the query but without identifying the source of inquiry) will be posted using the same method as the original posting of this (CFP) document. If the CFP has been advertised publicly, the results of any clarification exercise (including an explanation of the query but without identifying the source of inquiry) will be posted on the advertised source.

6. Amendments to CFP documents

At any time prior to the deadline for submission of proposals, UNWOMEN may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective proponent, modify the CFP documents by amendment. All prospective proponents that have received the CFP documents will be notified in writing of all amendments to the CFP documents. For open competitions advertised publicly, all amendments will also be posted on the advertised source.

In order to afford prospective proponents reasonable time in which to take the amendment into account in preparing their proposals, UNWOMEN may, at its discretion, extend the deadline for the submission of proposal.

7. Language of proposal

The proposal prepared by the proponent and all correspondence and documents relating to the proposal exchanged between the proponent and UNWOMEN, shall be written in English. Supporting documents and printed literature furnished by the proponent may be in another language provided they are accompanied by an appropriate translation of all relevant passages in English. In any such case, for interpretation of the proposal, the translation shall prevail. The sole responsibility for translation and the accuracy thereof shall rest with the proponent.

8. Submission of proposal

- 8.1. Technical and financial proposals should be submitted simultaneously but in <u>separate</u> emails or separate email attachments with the CFP reference and the clear description of the proposal (technical or financial) by the date and time stipulated in this document. If the emails and email attachments are not marked as instructed, UNWOMEN will assume no responsibility for the misplacement or premature opening of the proposals submitted.
 - Both email text bodies should indicate the name and address of the proponent and the description of the proposal (technical or financial). The technical email should not contain any pricing information; nor should the financial email contain any components of the technical proposal.
 - Technical proposals should be submitted in <u>one</u> (1) email accompanied by the forms prescribed in this CFP, clearly marked as technical proposal the email subject line and corresponding attachment should read:

- 8.2. Proposals should be received by the date, time and means of submission stipulated in this CFP. Proponents are responsible for ensuring that UNWOMEN receives their proposal by the due date and time. Proposals received by UNWOMEN after the due date and time may be rejected.
 - When receiving proposals by email (as is required for the CFP), the receipt time stamp shall be the date and time when the submission has been received in the dedicated UNWOMEN inbox. UNWOMEN shall not be responsible for any delays caused by network problems, etc. It is the sole responsibility of proponents to ensure that their proposal is received by UNWOMEN in the dedicated inbox on or before the prescribed CFP deadline.
- 8.3 The "Certificate of Proponent's Eligibility and Authority to Sign Proposal" contained in the Technical Proposal submission Form below must be executed by a representative of the proponent who is duly authorized to execute contracts and bind the proponent. Signature on the certificate represents that the proponent has read this CFP, understands it and agrees to be bound by its terms and conditions. The proponent's proposal with any subsequent modifications and counter-proposals, if applicable, shall become an integral part of any resulting contract.
- 7.4 Late proposals: Any proposals received by UNWOMEN after the deadline for submission of proposals prescribed in this document, may be rejected.

9. Clarification of proposals

To assist in the examination, evaluation and comparison of proposals, UNWOMEN may, at its discretion, ask the proponent for a clarification of its proposal. The request for clarification and the response shall be in writing and no change in the price or substance of the proposal shall be sought, offered or permitted. UNWOMEN will review minor informalities, errors, clerical mistakes, apparent errors in price and missing documents in accordance with the UNWOMEN Policy and Procedures.

10. Proposal currencies

All prices shall be quoted in Turkish Liras (TRY)

UNWOMEN reserves the right to reject any proposals submitted in another currency than the mandatory currency for the proposal stated above. UNWOMEN may accept proposals submitted in another currency than stated above if the proponent confirms during clarification of proposals, see item (8) above in writing, that it will accept a contract issued in the mandatory proposal currency and that for conversion the official United Nations operational rate of exchange of the day of CFP deadline as stated in the CFP letter shall apply.

Regardless of the currency of proposals received, the contract will always be issued, and subsequent payments will be made in the mandatory currency for the proposal above.

11. Evaluation of technical and financial proposal

- 11.1. PHASE I TECHNICAL PROPOSAL (70 points)
- 11.1.1.Only proponents meeting the mandatory criteria will advance to the technical evaluation in which maximum possible 70 points may be determined. Technical evaluators who are members of an Evaluation Committee appointed by UNWOMEN will carry out the technical evaluation applying the evaluation criteria and point ratings as listed below. In order to advance beyond Phase I of the detailed evaluation process to Phase II (financial evaluation) a proposal must have achieved a minimum cumulative technical score of 50 points.

11.2. PHASE II - FINANCIAL PROPOSAL (30 points)

11.2.1. Financial proposals will be evaluated following completion of the technical evaluation. The proponent with the lowest evaluated cost will be awarded 30 points. Other financial proposals will receive pro-rated points based on the relationship of the proponents' prices to that of the lowest evaluated cost

Formula for computing points: Points = (A/B) Financial Points

Example: Proponent A's price is the lowest at \$10.00. Proponent A receives 30 points. price is \$20.00. Proponent B receives $($10.00/$20.00) \times 30$ points = 15 points

12. Preparation of proposal

- 12.1. You are expected to examine all terms and instructions included in the CFP documents.

 Failure to provide all requested information will be at proponent's own risk and may result in rejection of proponent's proposal.
- 12.2 Proponent's proposal must be organized to follow the format of this CFP. Each proponent must respond to every stated request or requirement and indicate that proponent understands and confirms acceptance of UNWOMEN stated requirements. The proponent should identify any substantive assumption made in preparing its proposal. The deferral of a response to a question or issue to the contract negotiation stage is not acceptable. Any item not specifically addressed in the proponent's proposal will be deemed as accepted by the proponent. The terms "proponent" and "contractor" refer to those organizations that submit a proposal pursuant to this CFP.
- 12.3 Where the proponent is presented with a requirement or asked to use a specific approach, the proponent must not only state its acceptance, but also describe, where appropriate, how it intends to comply. Failure to provide an answer to an item will be considered an acceptance of the item. Where a descriptive response is requested, failure to provide the same will be viewed as non-responsive.
 - 12.4 The terms of reference in this document provides a general overview of the current operation. If the proponent wishes to propose alternatives or equivalents, the proponent must demonstrate that any such proposed change is equivalent or superior to UNWOMEN established requirements. 13 Format and signing of proposal

A proposal shall contain no interlineations, erasures, or overwriting except as necessary to correct errors made by the proponent, in which case such corrections shall be initialled by the person or persons signing the proposal.

14 Award

- 14.1 Award will be made to the responsible and responsive proponent with the highest evaluated proposal following negotiation of an acceptable contract. UNWOMEN reserves the right to conduct negotiations with the proponent regarding the contents of their proposal. The award will be in effect only after acceptance by the selected proponent of the terms and conditions and the terms of reference. The agreement will reflect the name of the proponent whose financials were provided in response to this CFP. Upon execution of agreement UNWOMEN will promptly notify the unsuccessful proponents.
- 14.2 The selected proponent is expected to commence providing services as of the date and time stipulated in this CFP.
 - 14.3 The award will be for an agreement with an original term of 1 year with the option to renew under the same terms and conditions for an additional period or periods as indicated by UNWOMEN.
